House Rules

The MSYC Steward is the on site representative of the Club.

The following house rules have been formulated with consideration for your fellow members and guests being an essential factor.

- 1. Club facilities are available to members in good standing as per Bylaw Article XI, Section 3A.
- 2. Concerns, questions and suggestions regarding house rules should be directed to the Vice Commodore or the Club Steward.
- 3. All Brookhaven Town, State and Federal codes and regulations will be enforced on Club premises.
- 4. Each member will be held responsible for any damages to the Club property on his part or that of his guests and will be assessed for repairs or replacement.
- 5. Appropriate attire is expected of all. Bathing suits, bare feet and bare tops are not permitted in the Clubhouse.
- 6. Cooperation of all members & guests is requested to see that the Club premises and docks are kept clean and orderly. Refuse should be deposited in appropriate containers/dumpsters.
- 7. All postings within the clubhouse must have authorization (Club Secretary approval) as outlined in our Bylaws, Article VI, Section # 5.
- 8. Members are responsible to supervise minor children. They are not allowed in the bar area. It is recommended that children under 6 (six) years of age wear life vests on the ramps / docks.
- 9. The Club Galley is off limits while meals are being served. The galley must be left in a clean and orderly condition at all times.
- 10. Only authorized personnel are permitted behind the bar.
- 11. No alcoholic beverages may be taken off the premises, as per the Club's liquor license.
- 12. Club chits may only be used to purchase beverages, food and tickets for social events, nothing else. (No ships store items, fuel, etc.)
- 13. Each member should be alert for any unauthorized non-members entering our premises and report them to the Steward or Club Officer.

- 14. Guests are welcome to use the Club facilities when accompanied by a member. All guests are required to be signed in our logbook by a member. This will be enforced at all times. The member is expected to ensure that his guests abide by the rules and traditions of the Club. Guests must leave when the member who signed him in leaves.
- 15. Only members and members' guest's vehicles will be permitted to park on Club property.
- 16. No running anywhere on Club premises.
- 17. NO SWIMMING is permitted on the Club's waterfront, inclusive of docks or boats at docks.
- 18. The outside Bar-B-Q is for members and guests to use. Be considerate and clean up the area after using it. Deposit all trash in the containers that are available. Please do not litter. CAUTION! The gas must be turned off.
- 19. Respect the personal property of others on the Club grounds.
- 20. Except for guide dogs, animals are not permitted in the Clubhouse or on the docks. All animals, while on Club grounds, must be on a leash.
- 21. Club property may not be removed from the premises without the Steward's approval.
- 22. The clubhouse will be closed Christmas Eve at 1800 hours, and all day Christmas, Easter and Thanksgiving.
